





- 4.) What barriers or challenges need to be overcome to realize that potential?







Global Compact Country Network Survey Responses

Successful Collaborations: Academic

- Course assignments & MSc Theses GCCN Sweden and Finland matched companies with students and GCCN Switzerland & Liechtenstein, Sweden on MSc theses
- Regional field trips field trips to GCCN France HQ
- Co-develop new programs Attending a regional GCCN France meeting and contacting a corporate member inspired a new undergraduate educational workshop partnership







Successful Collaborations: Professional Development

- **Joint training programs and webinars** develop and deliver Carbon, Climate, and Biodiversity Literacy workshops (Denmark) & training programs for business leaders at the regional level (Colombia), on human rights in business (Austria), anti-corruption (Switzerland & Liechtenstein).
- **Exploratory meetings** GCCN Pakistan held meetings with the leading business schools and HEI Ministers







Successful Collaborations: Research

- **Joint research projects** the first study on the impact of corruption on development in Latin America (Mexico)
- **University Indicators** PRME Chapter LAC and GCCN Colombia developed a system of social responsibility indicators for HEI
- Cross-country research on private-sector policy enablers (Egypt)
- Market research SDG measurement/disclosure by ASX150 companies (Australia).
- On-demand research GCCN Brazil and PRME Chapter Brazil

 Pakistan, Switzerland & Liechtenstein
- Need a clear value proposition Germany, Norway, Switzerland, Thailand & UK
- Institutional prioritization business schools prefer UNGC over PRME
- Lack of precedent and structured formats- New Zealand, Kazakhstan, Pakistan, Netherlands, Norway, Slovenia, Austria
- **Institutional, individual or no communication** USA, Denmark, Sweden
